## **LEGAL NOTICE**

## Terms of use of the website

- 1. Introduction. Please review these General Conditions of Use and our Privacy Policy before visiting or contracting the services offered on this website (hereinafter the "Portal" or the "Website"). By accessing the services of this Portal, the user declares that he/she has read, accepted and agrees to comply with these conditions of use. The user is understood to be the person who accesses, browses, uses or participates in the services and activities, whether free of charge or for a fee, carried out on the Website (hereinafter, the "User").
- 2. Ownership. - 3. Content of the website. The website www.fundacionbmarch.es contains a series of informative contents on the activities, services and facilities of the BMS FOUNDATION. This website provides users and the general public with information about the BMS FOUNDATION and its activities.
- 4. Terms and Conditions. These are the general conditions that regulate the access, navigation and use of the Portal, as well as the responsibilities derived from the use of its contents (hereinafter "Contents" are understood to be the texts, graphics, drawings, designs, codes, software, photographs, music, videos, sounds, databases, images, expressions and information, as well as any other creation protected by national laws and international treaties on intellectual and industrial property). FUNDACIÓN BMS may establish specific conditions that regulate the use and/or contracting of specific services offered to Users through the Portal.
- 5. Ownership of the Contents. FUNDACIÓN BMS is the owner or licensee of the intellectual and industrial property rights of the Contents of the Website. - 11. Responsibilities and guarantees.
